

# Terms and Conditions

## Online Golf Tournament Scoring Software

(OGTSS)

## 1. Acceptance of Terms

By accessing or using Online Golf Tournament Scoring Software (“OGTSS,” “the Software,” “the Service”), you agree to be bound by these Terms and Conditions. If you do not agree, you may not use the Service.

## 2. Description of Service

OGTSS is a subscription-based, web-accessible software platform designed to manage golf tournaments, including player management, scoring, reporting, and related tournament functions.

## 3. Eligibility

You must be at least 18 years old and legally capable of entering into a binding agreement to use OGTSS.

## 4. Subscription Plans

OGTSS is offered under the following subscription options:

- **Monthly Subscription**
- **Yearly Subscription**

Subscription features, pricing, and billing intervals are displayed at the time of purchase and may be updated periodically.

## 5. Billing and Payments

- Payments are billed in advance on a recurring basis (monthly or annually).
